



## Centra Credit Union Teaming up with Teachers OFFICIAL ACCOUNT AND PRIZE ENTRY RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.
2. **How To Enter.** Centra Credit Union's Teaming up with Teachers runs from 12:01am EST April 19, 2021 to 11:59pm EST April 30, 2021. Prize will be 4-\$500 Visa gift cards. Winning classroom must be in a county that Centra serves.

*To Be Entered Automatically:* Individuals who fill out the entry form provided at [www.centra.org/teachers](http://www.centra.org/teachers) will be entered to win a \$500 Visa gift card. Individuals submitting an entry must ensure they are the owner of any content they submit and have full rights to share the content. All entries submitted within the posted time limits of the Teaming up with Teachers promotion will be automatically entered. Facebook sharing will be open from May 3-7, 2021 and winners will be selected at random.

All entries become property of the Credit Union and may be used in current and future promotion of the Teaming up with Teachers promotion.

3. **Teaming up with Teachers.** There will be four (4) Prizes announced and awarded on or after May 10, 2021. The time of the drawing will be determined at the Credit Union's sole discretion. The winner(s) will be randomly selected from eligible entries.
4. **Prize.** There will be four (4) Prizes, and they shall be valued at a \$500.00 Visa gift card. All entries are eligible for only one prize. No cash or check will be awarded. The Prize is not transferable. The Winner will be contacted as close to the day of the drawing as possible based on available contact information and need not be present to win. The Winner is solely responsible for reporting and paying applicable state and federal taxes and must provide the Credit Union with valid identification and a valid Taxpayer Identification Number or Social Security Number before any Prize will be awarded.
5. **Odds.** Actual odds of winning depend on the number of eligible entries received.
6. **Eligibility.** Legal residents of the United States (except where prohibited by law) are eligible to participate and win. **All participants must be at least 18 years of age and the classroom must be located in a county that Centra serves. Centra Credit Union Team Members, officials, and their immediate family members are not eligible for the drawing.**
7. **Decisions.** By entering into the drawing, entrants agree to abide by and be bound by these Official Rules, and to accept the decisions of the Credit Union as final. Entrants also agree to hold the Credit Union and each of its officers, directors, Team Members, Members, representatives, and agents harmless from any liability arising from participation, or the acceptance of a Prize. The Credit Union and each of its officers, directors, Team Members, Members, and representatives, and agents are not responsible for any negligence, claims,

liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance of the Prize awarded or participation in this promotion. The Credit Union is not responsible for lost, late, misdirected, damaged, or incomplete entries; or are lost or not received due to any reason. The Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the promotion and Prize redemption.

8. **Publicity.** The Winner agrees to permit the Credit Union to use his/her name, entry information and content and likeness in promotional and other Credit Union materials, without additional compensation or permission, except where prohibited by law. The Winner also agrees that their name and prize amount will be given to other entrants upon request.

9. **Compliance with Law.** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and the Credit Union in connection with the promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Indiana, without regard to its choice of law provisions.

10. **Resolution of Disputes.** Except where prohibited by law, as a condition of participating in this promotion, each participant agrees that (1) any and all disputes and causes of action arising out of or connected with the promotion, Drawing or any Prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest Columbus, Indiana; (2) the laws of the State of Indiana will govern the enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction.
